Notes to Physician Refer to Section 11. Employees with Hepatitis B and/or HIV may develop viral resistance to anti-viral drugs of this class depending on the nature and duration of exposure to this material. Based on the opportunity for exposure to this material, employees with Hepatitis B and/or HIV should consult with an occupational health physician to address any potential concerns.

The need for a pre-placement physical examination and history for Medical Surveillance employees with potential exposure to this compound is to be evaluated by a physician that is thoroughly knowledgeable about both the toxicity of this compound and the extent of work place exposure. Baseline testing would include: a complete blood count with differential, a blood test for liver function, a blood test for kidney function, lung function test. Based on opportunity for exposure and duration of exposure a periodic follow-up examination may be considered. For employees with Hepatitis B and/or HIV handling this material, Medical Surveillance may include testing and/or counseling regarding use of additional personal protective equipment, additional engineering controls, and/or alternative work methods. Employees who are pregnant, are breastfeeding, or who are concerned with other reproductive issues should be encouraged to consult with the occupational health physician monitoring worker's health. Pregnant or nursing women should avoid exposure.
